CORPORATE PARTNER: \$5,000 - all the above, plus:

1. Additional vendor booth no charge, if needed. (**\$850** value)
2. No extra charges for extra associate meals @ festival (limit three)
3. Invitation to Presidents' Reception for two associates (w/introductions), plus dinner 2 tickets for banquet
4. Letter of endorsement, upon request, with use of association logo (final approval by Executive Director)

PLATINUM PARTNER: \$10,000 - all the above, plus:

1. **Category Exclusivity** guaranteed by NYSAAA, Inc. (**cash contributions only - not including in-kind**) services – exclusivity means that **no competing products or services** in that specific category will be endorsed by association
2. **One complimentary room night @ hotel for Thursday plus 2 tickets to Hall of Fame Luncheon or Banquet (w/intro) (\$200 value)**

DIAMOND PARTNER: \$20,000 - all the above, plus:

1. Up to two complimentary room nights at hotel (Wed. & Thurs.) (**\$270** value)
2. Complimentary meal package for up to two (includes festival, banquet and luncheon), if attended **with introduction and brief comments by one representative** (up to **\$300+** value)

(12/31/04). Payments of contributions will remain on a yearly basis.
